

ORDINANCE NO. 2008-02

AN ORDINANCE OF THE PAJARO VALLEY WATER MANAGEMENT AGENCY  
ESTABLISHING RULES AND REGULATIONS FOR RECYCLED WATER  
CUSTOMERS IN CONFORMANCE WITH TITLE 22 OF THE CALIFORNIA CODE OF  
REGULATIONS

WHEREAS, in 1984, the State Legislature formed the Pajaro Valley Water Management Agency (“Agency”) for the purpose, among others, of reducing long-term groundwater overdraft and seawater intrusion in the Pajaro Valley; and

WHEREAS, the Agency’s Revised Basin Management Plan (“BMP”), adopted by the Agency’s Board of Directors in 2002, establishes a comprehensive plan of projects and programs designed to increase the sustainable yield of the Pajaro Valley Groundwater Basin and halt seawater intrusion that threatens the Pajaro Valley’s groundwater supply; and

WHEREAS, the use of recycled water from the Watsonville wastewater treatment plant is a key source of supplemental water as outlined in the BMP; and

WHEREAS, the Agency and the City of Watsonville are nearing completion of the Coastal Distribution System and the Recycled Water Treatment Facility, with deliveries of recycled water anticipated by Spring, 2009; and

WHEREAS, the State Department of Public Health (DPH) and the Regional Water Quality Control Board (RWQCB) have issued regulations to ensure that recycled water is produced, distributed and used safely, and which require the Agency, among other things to establish and enforce rules and regulations for reclaimed water users, governing the design and construction of reclaimed water use facilities and the use of reclaimed water, in accordance with uniform statewide reclamation criteria established pursuant to State law (Cal. Water Code §13521; and

WHEREAS, the Agency’s *Rules and Regulations for Recycled Water Customers*, attached hereto and incorporated herein by reference, are designed to ensure that the Agency’s recycled water system is operated in accordance with these state laws and guidelines, as well as the adopted policies and procedures of the Agency Board of Directors.

NOW, THEREFORE, be it ordained as follows:

SECTION 1. Adoption of Rules and Regulations. The *Rules and Regulations for Recycled Water Customers*, attached hereto and incorporated herein by reference, are hereby adopted and shall apply to all recycled water customers of the Agency.

SECTION 2: Severability. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The Board of Directors hereby declares that it would have adopted this Ordinance and each section, subsection, sentence, clause, phrase or portion thereof, irrespective of the fact that any one or more section, subsection, sentence, clause, phrase or portion may be declared invalid or unconstitutional.



The General Manager of the Agency is hereby directed to publish a copy of this ordinance in accordance with the requirements of California Government Code Section 6063 in a newspaper of general circulation within the Agency boundaries.
